

**MRST REGISTRATION INFORMATION
2011-2012 SEASON**

Registration : (the following must be completed and on file prior to entering the pool)

- Team Registration form, Medical Release form and Middletown Parks and Recreation Insurance form.
- First Months Dues or First Installment (please refer to Payment Option Plan)
- **Registration Fees includes-** US Swimming Registration, Middletown Parks and Recreation Insurance Fee, Team Administrative Fee

Work Bond: All families must pay a **\$100 work bond fee**. Each family is required to volunteer at swim meets and participate in team fund raising. Participation is mandatory at home ESSL meets and at if your child is swimming , the ESSL Championships as well. ALL WORK BONDS WILL BE CASHED ONCE RECEIVED. Once a family’s work obligation is fulfilled, their work bond will be returned, or you may choose to donate it back to the team, or towards the Woody Memorial Fund for a graduating MRST swimmer. Please note that the team can not function and participate in these swim leagues without parent participation.

US MEET FEES Payment for meet fees will be due with entries for each meet. Please note that your swimmer will be entered in the meet when the event sheet and payment have been submitted to Coach Amy within the noted deadline. Once your swimmer has paid and registered for the meet there is no refunds of meet fees as the team is responsible to pay all registered meet entries.

ESSL Meets- ESSL meets are mandatory for all MRST swimmers. The only meet fees for ESSL are invitational meets, last chance meet and championships.

- There are no pro-rating of dues. One day in the water, constitutes one month of practice.
- There are no refunds on Options 2 unless specifically excused for medical reasons. A physician’s note is required.
- Monthly payments are due by the first of the month. If payments are not received before the 10th of each month, a \$25.00 late fee will be assessed.
- A \$25.00 returned check fee will be applied to any check returned for insufficient funds.
- Payments can be placed in the silver payment box at the pool or mailed to: MRST PO Box 762 Middletown, NY 10940
- Checks are to be made payable to Middletown Recreation Swim Team or MRST.
- The ONLY dues discount available is for Option 2- installment plan

TEAM SWIM SUITS- Ultimate Swim Shop is our authorized Speedo shop for suit purchases. Dates and pricing information to follow. These suits are **only** to be worn during team meets. Swimmers will need to purchase practice suits for daily use.

OPTION 1 - Monthly Payments are PER SWIMMER.

BRONZE \$45 SILVER \$55 GOLD / PLATINUM \$65

- Monthly dues will be waived for any Middletown Varsity Swimmer during their particular swim season. (Girls: September & October). (Boys: November, December & January).
- Written verification required from school sport coach for proof of participation.
- Monthly payments received over forty-five (45) days late will result in swimmer’s suspension until all fees are paid in full. Accounts must be made current in order for swimmer to be admitted back into the pool.
